DIRECTIONS TO THE LAW SCHOOL FROM I-90

1. Exit Hamilton Street (exit #282).
2. Proceed across bridge, north on Hamilton Street.
3. Turn left on Spokane Falls Boulevard (first traffic light).
4. Proceed one block and turn right onto Cincinnati Street.
5. Proceed one and a half blocks to School of Law parking lot.
6. Turn left into parking lot.
7. The Moot Courtroom is on the first floor of the law school building.

DIRECTIONS TO THE LAW SCHOOL FROM DIVISION/RUBY

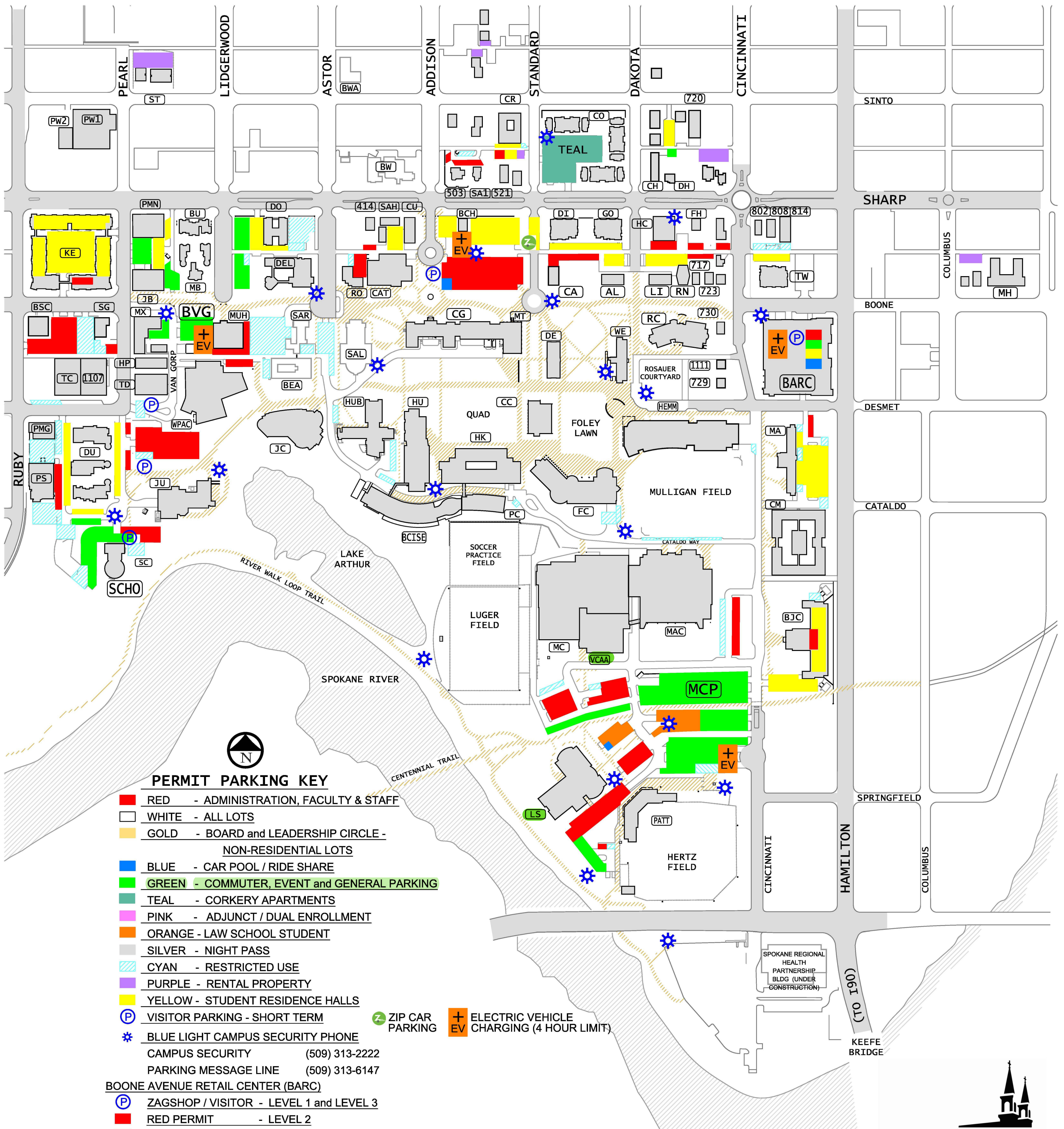
1. Turn east onto Sharp Avenue.
2. Proceed to Hamilton Street (9 or 10 blocks).
3. Turn right onto Hamilton Street (traffic light).
4. Turn right onto Spokane Falls Boulevard (traffic light).
5. Proceed one block and turn right onto Cincinnati Street.
6. Proceed one and a half blocks to School of Law parking lot.
7. Turn left into parking lot.
8. The Moot Courtroom is on the first floor of the law school building.

DIRECTIONS TO THE LAW SCHOOL FROM HAMILTON/NEVADA

1. Proceed south to Spokane Falls Boulevard (light just before bridge).
2. Turn right onto Spokane Falls Boulevard (traffic light).
3. Proceed one block and turn right onto Cincinnati Street.
4. Proceed one and a half blocks to School of Law parking lot.
5. Turn left into parking lot.
6. The Moot Courtroom is on the first floor of the law school building.

LUNCH LOCATION: VOLKAR CENTER (VCAA on the Parking Map)

The Volkar Center is slightly north of the Law School. Your lunch/meeting will be held in the Karen Gaffney Champions Room on the second floor in the Volkar Center. **A GU representative will be on hand to walk over with the group.
